Sub.: Supreme Court to hear the Company appeal against ban on December 5, 2016

Re: Disclosure under Regulation 30 of SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015

Dear Sirs,

The Company's appeal against the one-day ban on its Hindi channel will be heard next month by the Hon'ble Supreme Court (the Court).

Appearing for the Company, one of India's most famous lawyers, Mr. Fali Nariman, said that because the Government has suspended the ban, there is no urgent need to stay the order dated November 2, 2016 issued by the Ministry of Information and Broadcasting (MIB) against Company's Hindi news channel, 'NDTV India' directing it to stop the transmission or re-transmission of channel for 1 day from 00:01 hrs of November 9, 2016 till 00:01 hrs of November 10, 2016 and that the case can be heard a month later, during which the Company expects the Government to take a final decision.

Attorney General Mr. Mukul Rohatgi agreed that there was no urgency to pass any interim order. The Judges fixed December 5, 2016 for the hearing.

The Company has challenged the ban for violating the constitutional right to free speech and expression.

The ban was put on hold by the government yesterday after representatives of the Company met with Information and Broadcasting Minister Mr. Venkaiah Naidu. The Company reiterated that its Hindi channel did not broadcast sensitive details of the terror attack on the Pathankot air base and that its reporters did not share any information that was different from what other channels and newspapers presented at the same time.


